NON-FAIR AND OPEN AWARD FOR PRV VALVES

RESOLUTION AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT PRESSURE REDUCING VALVES FOR WATER SYSTEM

No. 23-03-C

WHEREAS, the Washington Township Municipal Utilities Authority ("Authority") has the need for a replacement Pressure Reducing Valves for the water system to ensure proper function; and

WHEREAS, proposals were solicited and price quotes were provided by two vendors; and

WHEREAS, Harper Control Solutions, Inc. ("Harper") submitted the most advantageous proposal dated February 28, 2023 indicating they shall provide pressure reducing valves; and,

WHEREAS, the proposal is estimated to be over \$17,500, but under the bid threshold of \$44,000; and

WHEREAS, the "Pay-to-Play" Law (N.J.S.A. 19:44A-20.4 et seq) requires that the resolution authorizing the award of a contract over \$17,500 without competitive bids and the contract for said services must be made available for public inspection; and,

WHEREAS, this is an award of a non-fair and open contract in accordance with N.J.S.A. 19:44A-20.5 and as required thereby: (1) the Qualified Purchasing Agent has determined and hereby certifies in writing that the replacement pump is anticipated to exceed \$17,500, (2) Harper will submit a Business Entity Disclosure Certification, (3) Harper will submit a certification that Harper has not made any reportable contributions to a political or candidate committee in the Township of Washington in the previous year, and (4) the Contract will prohibit Harper from making any reportable contributions through the term of the contract; and

WHEREAS, the Executive Director hereby certifies that adequate funds are available for these purposes; and, WHEREAS, the anticipated term of this contract will expire March 31, 2024; and

NOW, THEREFORE, BE IT RESOLVED by the Washington Township Municipal Utilities Authority:

- 1. Subject to attorney review, the Executive Director is hereby authorized and directed to execute the attached Proposal Agreement with Harper Control Solutions, Inc. to provide pressure reducing valves.

- 3. This contract is made without competitive bidding as the value is under the bid threshold in accordance with N.J.S.A. 40:11-3(a) and (c) of the Local Public Contracts Law.
- 4. A notice of this action shall be printed in the Authority's Official Newspaper within ten (10) days of the passage of this resolution.
- 5. This Resolution will take effect immediately pursuant to law.

WHEREAS, one condition of the allocation permit requires the Authority to contract with the New Jersey Water Supply Authority (NJWSA) for the consumptive portion of the increase in the Authority's allocation; and

WHEREAS, after investigation, it is recommended that the Authority execute a contract with the NJWSA for the consumptive portion of the increase in the Authority's allocation.

NOW, THEREFORE, BE IT RESOLVED by the Washington Township Municipal Utilities Authority in the County of Morris and in the State of New Jersey on this 21st day of March 2023 as follows:
